ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – Shane Griffith, driver of No. 6 IN A MINUTE, warned about properly controlling his horse after running up on the No. 1 ROCK OF ALL TIME in the far turn and stretch.

Race 3 – Delay between the third and fourth races as No. 1 JULERICA broke down after the finish and had to be vanned off the track.

Race 4 – Inquiry posted on unofficial fourth place finisher No. 3 CANTTOUCHMETHHERE (John DeLong) for possible violation of the breaking rule in the far turn after 3/4s. After a very short inquiry it was determined that driver DeLong complied with all aspects of the breaking rule and the horse was placed as finished.
