While driver John DeLong and trainer Roger Welch (connections of No. 4 FOR DAYZE) felt the horse should have been placed the judges did not feel that Husted jammed horses up entering the backstretch.

Race 8 - No. 6 FIFTY RIVERS held over for postrace blood gas testing after the horse's groom skipped out on prerace blood gas testing to

warm the horse up early.
