## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 5 – Ricky Macomber, driver of No. 8 TELL'S PURE POWER, warned about jamming horses up in the second quarter going to the half.

Race 8 – Inquiry posted on unofficial second place finisher No. 7 SKYWAY VICTRESS (Trace Tetrick) for possible violation of the pylon rule in the far turn after 3/4s entering the stretch. Video confirmed that horse was inside two pylons, however the judges determined that the horse did not gain an unfair advantage and was not lapped on at the finish. No reason for placing.

Race 9 – Superfecta wagering on the race cancelled with the two scratches reducing the field to five betting interests.
