ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 8- General inquiry posted regarding an incident occurring right before the half. No. 1 PONDA MAGIC (Rick Plano) made a break and while off stride caused interference to unofficial fourth place finisher No. 7 SMOKE BREAK (Kyle Wilfong). After reviewing video the judges determined that No. 7 SMOKE BREAK went inside pylons to avoid the breaking horse. This did not give an unfair advantage to the horse as 1) it was on a straight part of the track and 2) the horse lost ground to multiple horses prior to reentering the track. All horses placed as finished.

Race 11 - General inquiry posted looking at an incident going into the first turn before the quarter. After reviewing video the judges determined that unofficial fifth place finisher No. 5 PRIME IMAGE (Anthony Miller) made a break and scattered the field behind him. No. 1 TELL'SFIRSTGLIMPSE, No.2 MILO RAYMOND, No. 6 CALL ME DAD charted with interference breaks. No. 2 MILO RAYMOND did not finish the race due to the interference. No. 3 STRAIGHTBLUESKIES charted with interference. No. 5 PRIME IMAGE finished fifth placed unplaced for interference while on break (causing a horse not to finish).

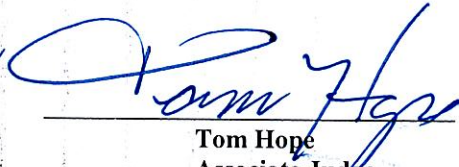

Separate inquiry posted on unofficial third place finisher No. 4 FREAKY LOVER (Marcus Miller) for possible violation of the breaking rule after the start and before the quarter. The judges determined that, while No. 4 FREAKY LOVER made an extended break, due to the circumstances of the race and the way the rest of the mile unfolded after the incident before the quarter to leave the horse placed as originally finished.

Race 13 – No. 5 BILLS IN JAIL (Kyle Wilfong) originally finished seventh placed eighth for violation of the breaking rule (extended break).
