ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 - Inquiry posted on unofficial fourth place finisher No. 4 ROCK I CAN (Kyle Wilfong) for possible violation of the breaking rule before and after 34. After reviewing video the judges determined that driver Wilfong complied with the breaking rule and the horse was placed as finished.

In the same race No. 8 R U AGAINST ME (Ronald Burks) originally finished fifth placed seventh for violation of the breaking rule in the stretch; extended break.

Race 4 - Inquiry posted on unofficial race winner No. 4 PASSIN WITH A SIGH (Jordan Ross) for possible violation of the breaking rule before and after the 1/4. After reviewing video the judges determined that the horse was off stride for more than 25+ strides which per IHRC rules constitutes an extended break. For violation of the breaking rule No. 4 PASSIN WITH A SIGH finished first placed fifth.

In the same race No. 1 PONDA AID (Robert Taylor) finished sixth placed seventh for an extended break in the stretch.

Race 7 - Inquiry posted on unofficial fifth place finisher No. 5 KING OF CASH (Trace Tetrick) for possible violation of the breaking rule after the start. After reviewing video the judges determined that the horse was off stride for more than 25+ strides which per IHRC rules constitutes an extended break. No. 5 KING OF CASH finished fifth placed seventh.
