After reviewing video the judges determined that No. 1 IN A MINUTE (Atlee Bender) made a break on his own after jumping a pylon and scattered the field behind him. No. 6 TESTYOURLUCK (Trace Tetrick) and No. 7 JASPER DIAMOND (Jordan Ross) charted with "i"'s (interference) and placed as finished. No reason to place No. 1 IN A MINUTE as the horse finished behind the horses it interfered with, however the horse was given an interference break "ix".
