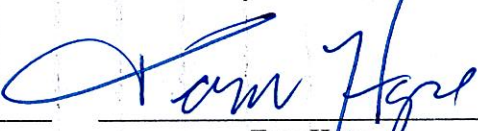
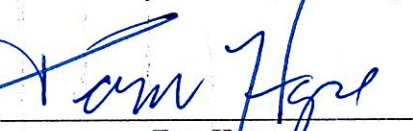
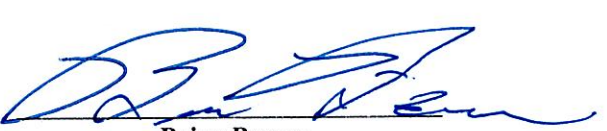

After reviewing video and speaking with Mr. Bender the judges determined that No. 2 AYE AYE CAPT RUSS drifted down into the path of No. 4 COUP STATION making contact with that horse. As the margin of victory was only a short head the judges deemed that was sufficient in costing No. 4 COUP STATION the win. No. 2 AYE CAPTAIN RUSS finished first placed second. No. 4 COUP STATION finished second placed first. Driver LeWayne Miller fined \$200.00 for interference.
