Race 13 – Inquiry posted on unofficial second place finisher No. 1 DC BATGIRL (Kyle Wilfong) and unofficial fourth place finisher No. 3 LAUREL COURT (Marvin Luna) for an incident at the top of the stretch. After reviewing video of the incident and speaking with both drivers, the judges determined that No. 3 LAUREL COURT bore in and struck the tire of No. 1 DC BATGIRL and made a break. While on the break No. 3 LAUREL COURT interfered with trailing horses. For interference while on a break No. 3 LAUREL COURT finished fourth placed seventh.
