Race 8 - Aaron Stutzman, driver of No. 8 FITTERJAKE, fined \$200.00 for failure to set and maintain a proper pace. Fine was increased from the standard \$100.00 due to it being in a Sire Stake going for \$66,000.

Race 11 - No. 8 TELLY'S WENDY (Kevin Lambright) originally finished sixth place seventh for a pylon violation from the half on. After making a break Mr. Lambright took the horse inside of the pylons for safety, however once back on stride the horse never was brought back onto the racing surface.

Race 12 – Inquiry posted on unofficial third place finisher No. 4 LISTENTOMENELSON (Marcus Miller) in the stretch. While on a break No. 4 LISTENTOMENELSON caused interference to unofficial fifth place finisher No. 5 DOUBLE A DAN (Matt Krueger) and failed to continuously lose ground while on the break. For multiple violations of the breaking rule, No. 5 LISTENTOMENELSON finished third placed seventh.
