ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 – Scratch of No. 4 BLUEBIRD LADYCHUCK reduced the field to five betting interests. Per IHRC wagering rules superfect betting on the race was cancelled.

Race 7 – No. 4 BIKINI CHASER originally finished fifth placed sixth for a pylon violation in the far turn before 3/4s. Driver Joey Putnam was inside two consecutive pylons and lapped on by a horse at the finish. For this violation driver Putnam was fined \$200.00

Race 11 – Scratches of No. 3 WHELK BLUE CHIP and No. 4 FULLY ADRAGON reduced the field from seven to five betting interests. Superfecta wagering on this race was cancelled as well.
