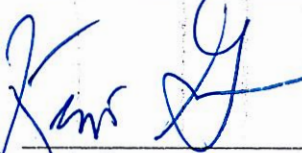

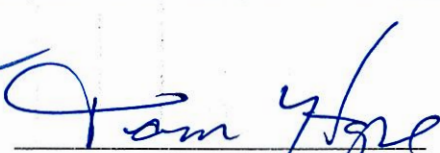

ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 11 - Inquiry posted on unofficial fourth place finisher No. 1 PONDA AVENUE (Marcus Miller) for possible violation of the breaking rule in the stretch. After reviewing video the judges determined that 1) the horse made an extended break and 2) driver Miller failed to continuously lose ground while on the break. For violation of the breaking rule No. 1 PONDA AVENUE finished fourth placed sixth. This placing moved unofficial sixth place finisher No. 3 JUST TEMPORAL (Doug Rideout) up to fifth. After reviewing his break, the judges determined that driver Rideout complied with the breaking rule and was officially placed fifth.
