After reviewing video, the judges determined that the horse bolted and in so doing caused interference to multiple horses. As a result, No. 7 TL THUNDER BOLT finished second placed ninth. Driver Atlee Bender was not penalized as the judges determined the interference was not a result of any of his actions.
