## **ADMINISTRATIVE ACTIONS, NOTES, COMMENTS**

Race 3 - Owner change on NO. 7 TOUGH MUSCLE to Sara Potts. Ordinarily an owner change is prohibited in claiming races by IHRC rules. This owner change was permitted with a waiver granted by the Indiana Horse Racing Commission after the race office failed to enter the new owner when the claim was processed a week ago.

Race 8 - Inquiry posted looking at an incident in the stretch. Unofficial fifth place finisher No. 3 GRAND REVIVAL (LeWayne Miller) made a break and was off stride through the finish. After reviewing video the judges determined the horse failed to lose ground while on the break and made an extended break. For violation of the breaking rule No. 3 GRAND REVIVAL finished fifth placed ninth.
