


### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


**Race 6** – No. 2 JESMACH ON TARGET was first time Lasix. Announcements made via tv scroll and track announcer. General inquiry posted focusing on the actions of No. 5 MAJORDANCEMOVES before the start. Video showed that the horse had an overcheck come off, however the judges determined that it was the result of the horse breaking stride and not unchecked prior to that. No. 5 MAJORDANCEMOVES treated as an official starter and charted with broken equipment at the finish.

**Race 8** – Willie Schwartz, driver of No. 4 BAD SHOT, fined \$200.00 for whipping with more than minimal wrist and elbow action while in the stretch.

**Race 14** – Kyle Wilfong, driver of No. 6 KIZZMELIKEUMISSME, fined \$200.00 for excessive whipping after the start.
