## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 – Inquiries posted on unofficial third place finisher No. 5 KARLEE GRACE (Robert Taylor) and unofficial fourth place finisher No. 4 BLUEBIRD TEMPEST (Kevin Lambright) for possible violation of the breaking rule before the start and at the finish respectively. After reviewing video the judges determined that both drivers complied with the breaking rule and furthermore No. 4 BLUEBIRD TEMPEST was not lapped on at the finish. The judges determined there was no reason to place either horse, and the results were made official.
