Race 2 – Inquiry posted on unofficial race winner No. 2 SKYWAY VICTRESS (Trace Tetrick) for possible violation of the pylon rule past the half entering the far turn. Video could only confirm that the horse was definitively inside one pylon while striking others. The judges determined the horse did not gain an unfair advantage and also that she did not interfere with trailing horses.

Race 8 – General inquiry posted looking at an incident at the top of the stretch after ¾. No. 7 IN THE PASSING LN (Atlee Bender) made a break on the lead. This caused interference to multiple trailing horses, however no reason for placing as the horse ended up finishing eighth out of eight in the field.

Race 10 – Marcus Miller, driver of No. 6 SOMEMORE BLUE, warned about setting too slow of a pace in the second quarter of the mile.

Race 12 – Greg Brumbaugh, trainer of No. 7 ENCHANTED OBSIDIAN, fined \$1000.00 for trainer responsibility violation and administration of a foreign substance within 24 hours of the horse's race as the owner was observed on paddock camera adding a foreign substance to the horse's water bucker. ENCHANTED OBSIDIAN was scratched by the judges.

Race 13 – No. 6 MONI MADNESS raced without trotting hobbles and qualified without trotting hobbles on July 2, 2025 at Hoosier Park. (Program error)

No. 10 SIR GEORGE (Kyle Wilfong) originally finished sixth placed ninth for violation of the breaking rule in the stretch (extended break).
