


Race 6 – General inquiry posted regarding an incident in late stretch nearing the wire when it appeared that unofficial third place finisher No. 4 LUCKY BENNY (LeWayne Miller) and unofficial fourth place finisher No. 7 FANFOSS (Joey Putnam) briefly came together. Driver Joey Putnam said it did not affect his horse any and the judges agreed with his assessment. Horses placed as finished.


Race 9 – Superfecta wagering on the race cancelled, per IHRC rules, with the field being reduced to five betting interests after scratches.

Inquiry posted on unofficial race winner No. 5 STAY GOLD (Case Bateson) for possible interference to No. 2 STRARZZNSTRIPES (Joey Putnam) around the far turn entering the stretch. Driver Joey Putnam said that while he may have been late it did not cost him position. With the video being inconclusive the judges determined there was no reason for placing.

Case Bateson driver of No. 5 STAY GOLD fined \$300.00 for whipping other than wrist action in the stretch.
