Race 11 - Inquiry posted on unofficial third place finisher No. 3 OMG AM I OK (Trace Tetrick) for possible pylon violation in the stretch. Video showed that the horse was inside one pylon, but the judges determined that this did not give the horse an unfair advantage. No reason for placing. Driver Tetrick fined \$100.00 for a pylon violation.
