Race 3 - Mike Oosting, driver of No. 5 TREACHEROUS ANGEL, fined \$100.00 for failure to set and maintain a proper pace in the second quarter of the mile.

Race 10 - Inquiry posted on unofficial fourth place finisher No. 3 SUNDAY SWAGGER (Kyle Wilfong) for possible violation of the breaking rule in the stretch. Video confirmed that the horse was in violation of the breaking rule for at least two different reasons: 1. The horse was on an extended break for over a 1/4 mile from after the 3/4 pole through the finish. 2. The horse passed horses while off stride. For violation of the breaking rule No. 3 SUNDAY SWAGGER finished fourth placed ninth.
