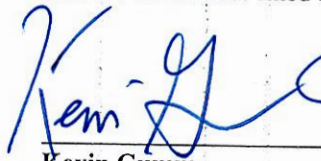
ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

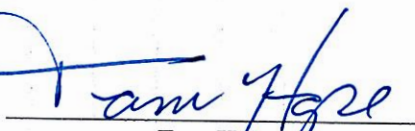

After reviewing video the judges determined that Mr. Miller was inside of one pylon and did not gain an unfair advantage as the horse was already in front of the field when it went inside of the pylon. Horse placed as finished.

Race 14 – Inquiry posted on unofficial second place finisher No. 2 BOOK THE FIGHT (Marcus Miller) for possible interference to unofficial fifth place finisher No. 7 NUMBER CRUNCHER (Marcus Miller) at the top of the stretch. After reviewing video and speaking with driver Marcus Miller the judges determined that No. 2 BOOK THE FIGHT came out late and caused No. 7 NUMBER CRUNCHER to alter course. For interference No. 2 BOOK THE FIGHT finished second placed fifth. Driver Jordan Ross fined \$200.00 for interference causing a placing.
