## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 9 – No. 3 AYE AYE CAPT RUSS (Trace Tetrick) originally finished seventh placed eight for interference to trailing horses while on a break before the 1/4.

Race 13 – Inquiry posted on unofficial fourth place finisher No. 4 BROOKVIEW GLIDER (Jordan Ross) for possible violation of the breaking rule after 3/4s entering the stretch. Video showed that the horse was knocked off stride by a breaking horse in front of him and therefore did not violate the breaking rule. Horse placed as finished.
