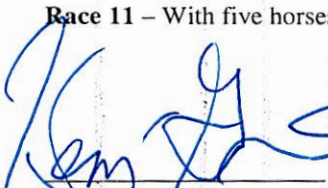

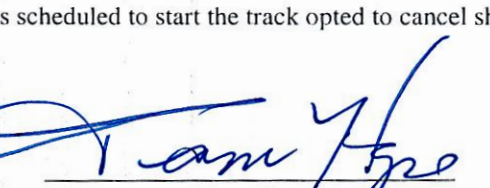
Race 2 - Kevin Lambright, driver of No. 4 SENSATIONAL, fined \$100.00 for failure to come up into position.

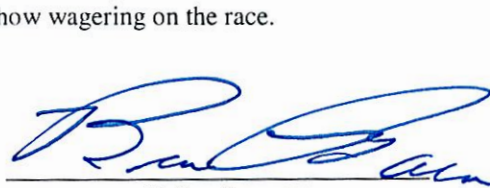
Race 3 - The 5/8 mile "Dash For the Cash" final was programmed at one mile. The Correct distance was announced to the public via TV and track announcer.
