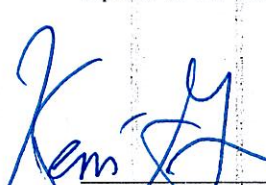

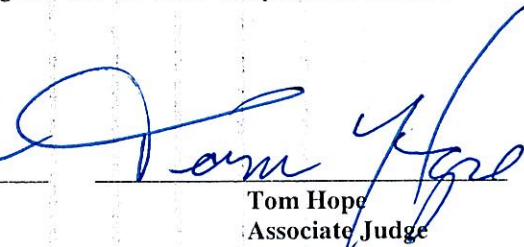
ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

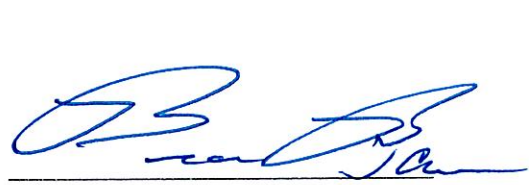
Race 1- Recall charged to No. 7 HES A JETTSETTER for interference to No. 6 JNM SON OF STAR for interference while on a break before the start.

Race 4- IKES SHOW STAR was first time Lasix. Trainer Justin White fined \$100.00 for failing to declare on Lasix resulting in a public announcement needing to be made.

Race 10 – Inquiry posted on unofficial fourth place finisher No. 7 DOUBLE A CHAPTER A (Travis Seekman) for possible violation of the breaking rule at the start. After reviewing video the judges determined that driver Seekman complied with all aspects of the breaking rule and the horse was placed as finished.
