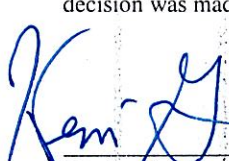

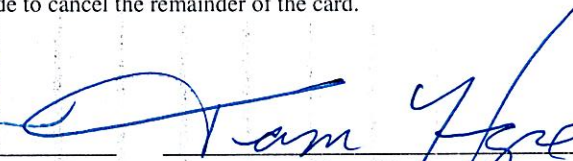
ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1- Inquiry posted on unofficial fourth place finisher No. 1 CLEAR AND COOL (Jordan Ross) for possible violation of the breaking rule at the start. After reviewing video, the judges determined that Mr. Ross complied and the horse was placed as finished.

Race 4- Inquiry posted on unofficial fourth place finisher No. 3 SURCHARGE (Matt Rheinheimer) for possible violation of the breaking rule in the stretch. After reviewing video, the judges determined that Mr. Rheinheimer complied with the breaking rule and the horse was placed as finished.

Race 8 – Weather delay beginning at 8:00 PM after the conclusion of the 7th race delaying the start of the 8th. After a 50-minute delay a decision was made to cancel the remainder of the card.
