ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - Superfecta wagering cancelled with the race scratching down to five betting interests.

Race 2 - No. 8 LIGHTHOUSE JESSE (Marvin Luna) originally finished eighth placed ninth for violation of the breaking rule in the stretch.

Race 4 – Superfecta wagering cancelled with the race scratching down to five betting interests.

Race 6 - No. 2 WHO GOES THERE scratched ineligible due to the fact it had finished second in a Sire Stake on July 8. Ken Rucker trainer of No. 6 GIRL MATH warned about leaving the paddock before being released from prerace blood gas testing.

General inquiry posted regarding the start. After reviewing video the judges determined that No. 4 KARLEE GRACE broke an overcheck after making a break behind the gate. With no recall for the broken equipment No. 4 KARLEE GRACE was declared a non-starter for wagering purposes and refunded.
