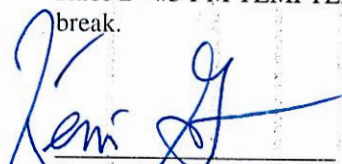

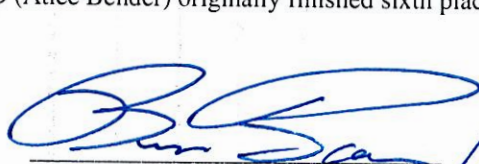

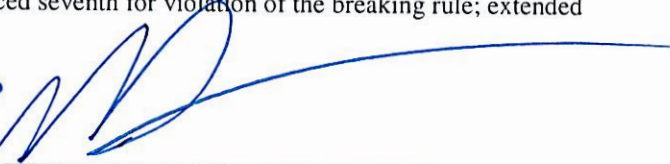
Race 2 - #5 I'M TEMPTED (Atlee Bender) originally finished sixth placed seventh for violation of the breaking rule; extended break.
