## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 2 – No. 3 DOUBLE A JASPER (Ross Leonard) originally finished fifth placed eighth for violation of the breaking rule in the stretch (extended break).

Race 4 – No. 8 THREEFIFTYTWO (Kevin Lambright) originally finished eighth placed tenth for a pylon violation after 3/4s entering the stretch.

Race 6 – Inquiry posted on unofficial fourth place finisher No. 2 DO'S N DON'TS for possible violation of the breaking rule going to the half. After reviewing video the judges determined that driver Doug Rideout complied with all aspects of the breaking rule and the horse was placed as finished.
