Race 2 – With the field reduced to five betting interests after scratches, superfecta wagering on the race cancelled due to IHRC wagering rules. The track opted to retain show wagering.

Race 3 – Inquiry posted regarding an incident at the top of the stretch between No. 1 POCKET OF TERROR A (Trace Tetrick) and No. 8 MULL OF KINTYRE (Brandon Bates). The judges determined that No. 8 MULL OF KINTYRE came out off the rail leaving the far turn and hooked No. 1 POCKET OF TEROR A. The situation was exacerbated by No. 9 PETER DALT (Case Bateson) hooking the already hooked horses causing driver Tetrick to be dumped off the race bike. The loose horse was caught by the outrider and driver Tetrick checked out okay. The judges will conduct hearings to determined appropriate penalties.

Race 12 - Clint Coy, driver of No. 8 TALENT SCOUT, fined \$200.00 for whipping with more than minimal wrist and elbow

action in the stretch.
