## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – No. 7 CHAPTERONEVERSEONE (Brandon Bates) originally finished sixth placed eighth for violation of the breaking rule (extended break).

Race 2 – Inquiry/objection posted on unofficial third place finisher No. 4 SHEZA DANCIN FOOL (Brandon Bates) for possible interference to unofficial fifth place finisher No. 6 DON'T FORGET ME (Carson Conrad) in mid-stretch right near the start of the passing lane. After speaking with both drivers and reviewing video the judges disallowed the objection. It appeared that both horses were running in. Horses placed as finished.

Race 6 – Inquiry posted on unofficial fourth place finisher No. 6 LADIES FIRST (John DeLong) for possible violation of the breaking rule in the stretch. Video confirmed that No. 6 LADIES FIRST was on a break before the wire and off stride through the wire. Photo finish confirmed that the horse was lapped on by 4 other horses while on a break. No. 6 LADIES FIRST finished fourth placed eighth for a lapped-on break.

Race 9 - Jordan Ross, driver of No. 3 E V COCOA, warned about giving holes nearing the half.
