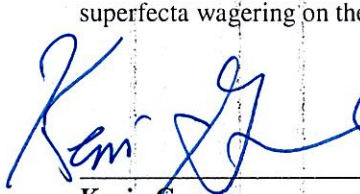

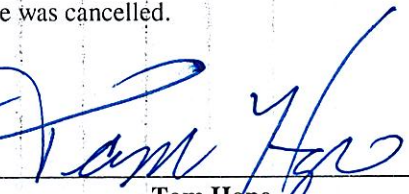
ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

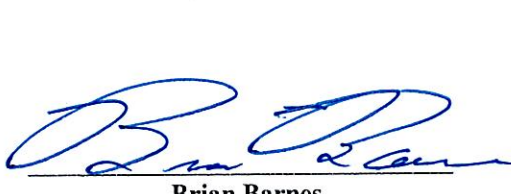

Race 5 – Todd Warren, driver of No. 6 WOODMERE HARRIET, fined \$200.00 for whipping with more than minimal arm and wrist action in the stretch.

Race 6- The scratch of No. 1 STARLITFRANKNSTEIN reduced the field to five betting interests. Per IHRC wagering rules, superfecta wagering on the race was cancelled.
