## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 7 – Inquiry posted on unofficial third place finisher No. 10 THE HIDDEN HERO (Jordan Ross) for possible violation of the breaking rule in the stretch. After reviewing video the judges determined that No. 10 THE HIDDEN HERO was still off stride through the finish and lapped on by two trailing horses. For violation of the breaking rule No. 10 THE HIDDEN HERO finished third placed fifth.

Race 9 – Inquiry posted on unofficial third place finisher No. 1 LUCKYSTAIR (Brad Ferguson) for possible violation of the pylon rule in the stretch. The judges spoke with Mr. Ferguson and he admitted that he never had room to get up the stretch and went inside pylons. However, the judges determined that this did not give his horse an unfair advantage. Horse placed as finished.

Ricky Macomber, Jr., driver of No. 6 HANDSOME CHARACTER, fined \$100.00 for failing to set and maintain a proper pace in the second quarter.

Race 11 - No. 2 PONDA LAMBO (Matt Riggle) originally finished seventh placed eighth for interference to trailing horses while on a break

before the 3/4s.
