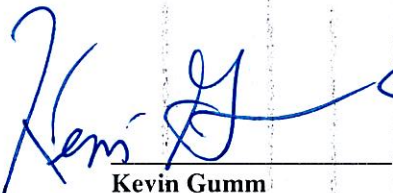

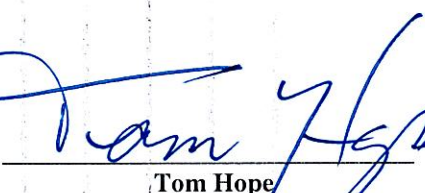

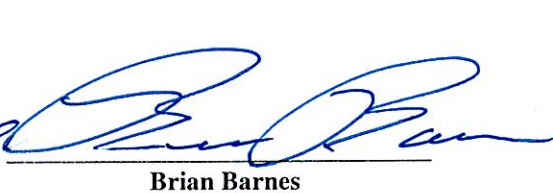
Race 2 – Ross Leonard, driver of No. 10 COMPATIBLE, fined \$200.00 for whipping with more than minimal arm and wrist action.
