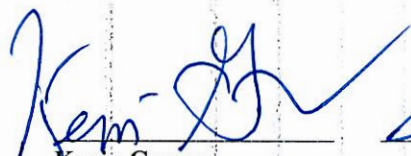

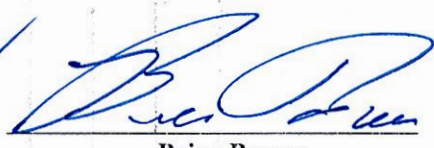

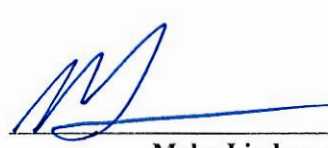
Race 4 - Randall Finn, driver of No. 7 WILD EYED GIRL, fined \$200.00 for failure to keep a line in each hand throughout the mile and use of the whip one-handed in the stretch.

Race 5 - No. 5 I'LL HAVE A DOUBLE was first time Lasix. Announcements made via track announcer and TV scroll. Inquiry posted on unofficial fourth place finisher No. 6 PONDA BUGATTI (John DeLong) for possible violation of the breaking rule after the start. After reviewing video the judges determined that Mr. DeLong complied with the breaking rule and the horse was placed was finished.

Race 13 - No. 7 FLOSSY HILL did not finish due to a broken hobble. With broken equipment causing the DNF the horse will not have to qualify.
