

ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


Race 1 – First race went off at 6:54 due to heavy rain and lightning in the area.

Inquiry posted on unofficial second place finisher No. 1 WASTINGNOTIME (John DeLong) for possible violation of the breaking rule after the start. Video showed that driver DeLong complied with the breaking rule, however the horse was off stride for more than 25 strides, By rule, that is an extended break. No. 1 WASTINGNOTIME finished second placed seventh.

Race 3 -14 – The remainder of the races cancelled due to unsafe track conditions caused by the rain.
