


HORSES PLACED ON LISTS

ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 9 – No. 4 GOODNESS GRAYCIOUS (Marvin Luna) broke a hobble during the horse, pulled up, did not finish. Due to the broken equipment the horse will not have to requalify.

Race 10 – Inquiry posted on unofficial race winner No. 6 GALLEYS IMAGE (Patrizio Ancora) for possible interference to No. 5 CHEDDA CHEDDA (Jordan Ross) in the stretch. While No. 6 GALLEYS IMAGE drifted in the stretch, the judges determined that No. 5 CHEDDA CHEDDA was not affected by the drifting as driver Jordan Ross never stopped driving on his horse and a disqualification would not be warranted in this situation. However, the judges did warn Mr. Ancora about allowing his horse to drift out in the stretch.
