## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 – Inquiry posted on unofficial fourth place finisher No. 7 CLOSED DEAL (LeWayne Miller) for possible violation of the breaking rule in the stretch. Video showed that No. 7 CLOSED DEAL made a break nearing the finish and was off stride through the finish. No. 7 CLOSED DEAL was lapped on by unofficial fifth place finisher No. 1 LIBBYS COOL CAT (Kyle Wilfong). For violation of the breaking rule, lapped on break, No. 7 CLOSED DEAL finished fourth placed fifth. \*Even if the horse was not found to have violated the breaking rule a disqualification was still likely because the horse went inside of two consecutive pylons in the last turn before ¾.\*

Race 7 - Donald Gribbin, Jr. upgraded from a "QF" to a "P" driver.

Race 10 – Superfecta wagering on the race cancelled per IHRC wagering rules as the field was scratched from six to five betting interests.

Recall caused by No. 6 KB'S SUMMER BREEZE due to broken equipment.
