## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 – Inquiry posted on unofficial fourth place finisher No. 4 SHADYJAKE (Trace Tetrick) for possible pylon violation in the far turn after 34. Video was inconclusive as to whether Mr. Tetrick was inside of two pylons or inside one and struck another. The judges erred on the side of caution only going with the one pylon they could clearly see and determined that this did not give the horse any unfair advantage. For the reason stated above the horse was placed as finished.

Race 10 – The test barn reported possible welts on No. 1 GRACEFUL DESIGN (Andrew McCarthy). Driver Andrew McCarthy fined \$300.00 for the violation.
