


Race 3 - No. 9 AINT SHE FANCY (Cristina Pacheco) declared a non-starter for wagering purposes after failing to make the fair start pole. Refunds issued on all wagers involving No. 9 AINT SHE FANCY.


Race 8 - Inquiry posted on unofficial fourth place finisher no. 5 FIRST RESPONDER (Cristian Pacheco) for possible violation of the breaking rule entering the first turn before the ¼. After reviewing video the judges determined that No. 5 FIRST RESPONDER was in compliance with the breaking rule and the horse was placed as finished.

Race 9 - Inquiry posted on unofficial second place finisher No. 1 FLIPPIN LADYLUCK (Trace Tetrick) for possible violation of the breaking rule after the start. After reviewing video the judges determined that No. FLIPPIN LADYLUCK was in compliance with the breaking rule and the horse was placed as finished.

No. 3 SUNSHINEOFMYLIFE (LeWayne Miller) originally finished fifth placed sixth for a lapped on break.
