After reviewing video the judges determined that No. 5 LAKESIDE TAMMY made a break on her own and in so doing caused interference to unofficial sixth place finisher No. 7 GREAT PRETENDER (Kyle Wilfong). For interference while on a break No. 5 LAKESIDE TAMMY finished fourth placed sixth. No penalty to driver DeLong. No. 6 MELLOW FELLOW (Jared Finn) pulled up with broken equipment (hobble) after the start.
