
Race 5 – No. 6 ATLANTIC SUMMER raced without shoes. Announcements made via track announcer and TV scroll.


Race 6 – Scratch of No. 1 A COOL MOMENT reduced the field to five betting interests. Per IHRC rules superfecta wagering on the race was cancelled.


Race 12 – Inquiry posted on unofficial race winner No. 5 WHOOMP (John DeLong) for possible interference to No. 8 LYONS I WANNA CHIP (Tim Tetrick) and No. 1 CRUISEN HALLE (Kyle Wilfong) in the far turn before 3/4s after No. 8 LYONS I CHIP made a break. While No. 5 WHOOMP appeared to throw in some bad steps in that turn it was unclear whether that was what caused No. 8 LYONS I CHIP to make a break. The judges spoke with driver Tim Tetrick who said that "it was a racing deal and he overreacted." Based on Tetrick's testimony and no clear video evidence the judges had no choice but to leave all horses placed as finished.

Recall caused by No. 9 SHACARI (Chris Page) scoring out of position. Driver Page fined \$100.00 for scoring out of position.

Race 13 – No. 1 CHAPERCRAZ was a late vet scratch due to lameness. Initially the horse was going to race without shoes, the assistant trainer asked permission to put rear shoes back on, which was granted by the judges as there are no rules in Indiana which prohibit the practice. After putting rear shoes on the horse was scratched by the track vet due to lameness. Due to the delay this caused trainer Ron Burke is fined \$500.00 for failing to have the horse properly equipped and delaying the start.
