### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

**Race 1** - No. 3 STARS DREAM was first time Lasix.

**Race 3** - Inquiry posted on unofficial second place finisher No. 6 FLIPPIN LADYLUCK (Trace Tetrick) for possible violation of the breaking rule in the first turn going to the quarter. The judges determined, after looking at the video replay, that Mr. Tetrick complied with the breaking rule. Horse placed as finished.

**Race 10** - No. 10 WELL DRESSED SWAN was also first time Lasix. Announcements on both horses made via track announcer and TV scroll.

Inquiry posted on unofficial fourth place finisher No. 9 SWAN SHORES (Jordan Ross) for possible violation of the breaking rule after the start. After reviewing video the judges determined that Mr. Ross complied with the breaking rule and there was no reason to place the horse.
