Race 1 – Devon Tharps fined \$50.00 for failure to drive No. 2 BEACH PRO when programmed.

Race 12 – No. 3 VERGE OF INSANITY was a late vet scratch after tying-up in the paddock.

General inquiry looking at an incident in the far turn. Video shows No. 5 FOX VALLEY CAIRO (Kyle Wilfong) make a break before 34 causing interference to No. 1 COLLETTES and No. 2 OHHLEPMEBABY. No. 5 FOX VALLEY CAIRO failed to finish the race

Race 13 - Inquiry posted on unofficial race winner No. 6 SKYWAY MATERPIECE (Atlee Bender) for possible pylon violation before ¾. Video confirmed that Mr. Bender's race bike wheel was inside of two pylons, but the horse was not lapped on at the finish and the judges determined it did not give the horse an unfair advantage. No reason for placing and no penalty to Mr. Bender as the horse was running in.
