


Race 1 – First race went without an outrider. The drivers were asked if they felt comfortable to go without one and they unanimously voted to do so. She showed up in time for the second race.

Race 5 – Superfecta wagering on the race cancelled, per IHRC wagering rules, after the scratches of No. 6 MAGGIE RHEE and No. 7 MARVELOUS MARSHIA reduced the field to five betting interests.

Race 9 – Inquiry posted on unofficial third place finisher No. 2 SIMPLY VOLO (Jordan Ross) for possible violation of the breaking rule after the start. The judges determined that driver Ross complied with the breaking rule. No reason for placing.
