## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 – With the scratch of DOUBLE A DALLAR the field was reduced from five to four betting interests. Per IHRC wagering rules, trifecta wagering on the race was cancelled. The track also opted to cancel place and show wagering on the race. Inquiry posted on unofficial third place finisher No. 1 YO ABBY (LeWayne Miller) for possible violation of the breaking rule after the start. After reviewing video the judges determined that No. 1 YO ABBY did not violate the breaking rule and was placed as finished.

Race 10 - Recall attributed to a gate malfunction (wrong gear selected).
