**ADMINISTRATIVE ACTIONS, NOTES, COMMENTS**

**Race 6** – Inquiry posted looking into an incident going to the half. Video showed that No. 5 DON'T FORGET ME broke a hobble going to the half which caused the horse to make a break. While off stride the horse was taken to the inside where Mr. Conrad's sulky wheel caught a light post causing him to be dumped from the race bike. Both horse and driver were checked out by the track vet and paramedics respectively and cleared. No. 8 JN ORPHAN LADY (LeWayne Miller) pulled up in the stretch with a broken hobble.

**Race 7** - Inquiry posted on unofficial third place finisher No. 1 JOANNAS DREAM (Jordan Ross) for possible interference to unofficial fifth place finisher No. 5 PILOT'S DESTINY (Matt Krueger) around the far turn going to  $\frac{3}{4}$ . Video shows No. 1 JOANNAS DREAM come out and almost hook No. 5 PILOT'S DESTINY which was confirmed by both drivers when speaking to them. Video also shows that this incident also caused unofficial eighth place finisher No. 4 LADY BY A NOSE (Brad Ferguson) to make an interference break. No. 1 JOANNAS DREAM finished third placed eighth for interference to trailing horses. Driver Jordan Ross fined \$200.00 for interference.

**Race 9** – General inquiry posted looking into breaking horses in the far turn. These breaks did not affect the official order of finish in the race.
