Race 3 – No. 7 MILK OF THE POPPY was a regular Lasix user. Announcements made via tv scroll and track announcer.

Race 5 – Jared Seekman, driver of No. 1 MY RICH UNCLE, and Mike Oosting, driver of No. 8 FIXN AND MIXN, warned about using too much elbow action while whipping in the stretch.

Race 6 – Inquiry posted on unofficial third place finisher No. 6 ATLANTIC WAVE (John DeLong) for possible interference in the passing lane to unofficial fifth place finisher No. 1 KATE'S GIRL (Brad Ferguson). After reviewing video and speaking with







both drivers the judges determined that Mr. Ferguson had the right to the passing lane, however he ceded his position to Mr. DeLong allowing his horse to skirt through against the pylons. No violation and the horses were placed as finished.

Race 7 – No. 4 DOUWANNROCK (Matt Krueger) originally finished eighth placed ninth for a pylon violation in the stretch.

Race 11 – Inquiry posted on unofficial No. 4 SUPRIZE ME WENT (Atlee Bender) for possible pylon violation in the stretch. Mr. Bender was inside multiple pylons in the stretch but did not gain an unfair advantage. The judges did not place the horse but did fine Mr. Bender \$100.00 for the pylon violation.
