Race 5 - Separate inquires posted on unofficial first place finisher No. 2 SWAN DIEGO (John DeLong) and unofficial second place finisher No. 3 NO LINGERING (Kyle Wilfong) both for incidents in the far turn before three-quarters. No. 2 SWAN DIEGO was inside two pylons, however the horse was not lapped on and deemed not to have gained an unfair advantage. Horse placed as finished, but driver DeLong fined \$100.00. No. 3 NO LINGERING was a possible violation of the breaking rule. The horse was off stride briefly, and driver Wilfong complied with all aspects of the breaking rule. No reason for placing.

Race 9 - Marvin Luna, driver of No. 1 HOT MESS EXPRESS, fined \$200.00 for failure to set and maintain a proper pace for

the class in which he was racing.
