ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 6 – Inquiry posted on unofficial second place finisher No. 2 TUGGIN THOMAS (Ricky Macomber, Jr.) for possible violation of the breaking rule after the start. After reviewing video the judges determined that Mr. Macomber complied with all aspects of the breaking rule and the horse was placed as finished.

Race 13 – Inquiry posted on unofficial third place finisher No. 9 ANDOVERTHEWINNINGS (Kyle Husted) for possible pylon violation in the far turn. Video showed that the horse was inside of four consecutive pylons before both wheels reentered the racing line. Per IHRC rules any horse inside of three or more consecutive pylons without correcting course may be placed last which the judges opted to do in this situation. No. 9 ANDOVERTHEWINNINGS finished third placed ninth.
