Race 6 - No. 1 HELPTHENEEDY originally finished sixth placed seventh for violation of the breaking rule; extended break.

Race 13 – Inquiry posted on unofficial third place finisher No. 1 SUNDAY SWAGGER (Kyle Wilfong) for possible violation of the breaking rule in the stretch. After reviewing video the judges determined that the horse was lapped on by two horses at the finish and was also in violation of the breaking rule due to an extended break. No. 1 SUNDAY SWAGGER finished third placed seventh.
