ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - Inquiry posted on unofficial third place finisher No. 5 DONT TALK DIRTY (Clint Coy) for possible interference to trailing horses going up the backside. Drivers Kiwon Waldron and Brad Ferguson both agreed that Mr. Coy's actions jammed the field up and caused confusion. Mr. Ferguson also stated that's the reason his horse made a break which is supported by the video of the race. For jamming up and causing confusion to trailing horses No. 5 DONT TALK DIRTY finished third placed seventh. Driver Clint Coy fined \$200.00 for causing interference and jamming the field up.

Separate inquiry posted on unofficial fourth place finisher (placed third via DQ) No. 7 CHROMYS ROCKET (Jordan Ross) for possible violation of the breaking rule after the start. After reviewing video the judges determined that Mr. Ross complied with the breaking rule and was placed as finished.

Race 3 - Ronald Burks, driver of No. 3 RBSLUCKYSHADYDAISY, warned about using more than minimal wrist and elbow action in the stretch.

Race 12 - Inquiry posted on unofficial second place finisher No. 9 JOEY JOE (Jordan Ross) for possible violation of the breaking rule entering the first turn approaching the 1/4. After reviewing video the judges determined that Mr. Ross complied with the breaking rule and the

horse was placed as finished.
